## **FINANCIAL**

## **Monthly Statements**

Trish Dye reviewed the financials through December 31, 2017 for the board.

Ms. Dye highlighted operations expenses as well as the surplus to budget. The board discussed the importance of having cash on hand for the upcoming ADA unit.

# Manager's Report

She stated she'd had someone come out to look at the damage; for approximately \$36K the roofs could be repaired before the monsoon season. Roofs were not scheduled in reserves until 2022.

Jeffrey Abramowitz requested a few more quotes for the roofing project. The board would review them via email to enable moving forward prior to monsoon season.

#### **ADA Compliance - Update**

Trish Dye advised the cost of constructing the ADA unit had risen about \$10K with the addition of specific adjustments to wiring, the patio level and kitchen cabinetry to ensure the unit was up to city code.

A motion to approve the new ADA unit construction at the increased estimated cost of \$146,695 was made by John Holwager, seconded by Rosemary Callard-Szulgit and approved.
